Pursuant to Regulation 30 read with Schedule III of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby inform to the Exchanges that Navkar Corporation Limited (“Company”) has previously received the show cause notice demanding tax and penalty of Rs.15,61,512/- on account of expiry of validity of E-way bill at the time of interception of vehicle in movement which was earlier communicated vide Ref: NCL/CS/2024-25/26 dated September 14, 2024. Now in respect of the same case, company has received new Show Cause Notice u/s 129(3) of the Goods & service Tax act, 2017 imposing only penalty of Rs. 10,41,846/-.
